NEUROSKIN SKIN CARE PRODUCTS

But relief has arrived. **NEUROSKIN** products, developed by **avVaa World Healthcare Products** (Lumby, British Columbia), are created from patented science developed to relieve symptoms of psoriasis, acne, seborrheic dermatitis and itchy skin—all with the convenience of over-the-counter availability.

Of interest is the fact that one of the inert ingredients present in the NEUROSKIN products is silicon, in its biologically active amorphous form, silicic acid. While not listed as one of the active ingredients of the product, it is known to have benefits for the skin. As a trace mineral, silicon is an essential component to good health. In healthy individuals, the highest concentration of silicon is found in the skin and bones. Silicic acid has a vital role in many fundamental skin processes: stabilizing collagen which increases the skin's integrity, elasticity, and protective function; promoting moisture retention; binding free radicals, providing an important antioxidant and anti-inflammatory function; which together, allows damaged skin to heal. "avVaa's approach," according to Mark Alden, MD, Clinical Associate Professor, Drexel University College of Medicine (Philadelphia, PA), "is to promote healthy skin. And we believe that healthier skin will have fewer ailments."

NEUROSKIN has been tested in several clinical trials not sanctioned by the FDA. The data from these trials has not been reviewed or approved by the FDA. In one trial conducted

in Germany on patients with eczema, researchers noted after four weeks a 63 percent decrease in symptoms of erythema, a 70 percent reduction in skin scaling, a 62 percent improvement in infiltration, and a 45 percent reduction in itching. No adverse events were reported. At the 42nd National Dermatology Congress in Rimini, Italy (2004), similar results were reported in two separate trials (not FDA sanctioned) for psoriasis and eczema. "While avVaa is not making any health claims based on these studies, nor on the inert ingredient, silicic acid," states Dr. Alden, "we consider these results remarkable." One of the goals of avVaa is to initiate a New Drug Application with the FDA, naming silicic acid as the active ingredient. Even as it is now, NEUROSKIN is an FDA registered OTC product for the relief of symptoms from psoriasis, seborrheic dermatitis and acne," continues Dr. Alden. "This product will fill a huge gap in patients' needs. For some, they may choose it over prescription medications. For others, it will be what they use between expensive therapies or steroids. What is more, it fits with the attitudes of this century, which are to go more natural and avoid potentially toxic substances."
